






BRITISH HORSERACING AUTHORITY

QUALIFICATION OVERVIEW

BUSINESS ADMINISTRATOR WITHIN RACING

Level: 3 (A-Level equivalent)

Duration: 18 months


DEVELOPING SKILLS

A Business Administrator within Racing will learn a range of knowledge, skills and behaviours, including:

- Acquiring insights into race day logistics, financial operations, and marketing.
- Understanding the complete structure of the industry, and all relevant legislation.
- Learning how to administer billing, process invoices and create purchase orders.
- Building and sustaining relationships with new and existing stakeholders and suppliers.
- Utilising project management tools to plan, monitor, and report effectively.
- Demonstrating confident communication and teamwork.

UNIQUE ACCESS TO THE RACING INDUSTRY

Learners will take part in a BHA Overview Day hosted by a range of racing professionals, exploring racing administration, rules, ownership, and key industry challenges. Tailored visits to racecourses or race yards will further immerse individuals in the racing world, connecting their roles directly to the heart of the sport.

LEARNER INFORMATION

FUNCTIONAL SKILLS

Maths and English qualifications are a core component of apprenticeships. Delivered directly by Haddon Training, these can be taught through individual or group sessions tailored to each learner's needs. If an apprentice has already achieved equivalent qualifications, such as GCSEs or prior Functional Skills, they may be exempt from this requirement.





END POINT ASSESSMENT

The apprenticeship concludes with an End Point Assessment (EPA), incorporating an online test, a professional discussion based on knowledge gained during the programme, and a short presentation on a completed project or process the learner has improved. Apprentices also prepare a portfolio of evidence as a reference for the discussion. Apprentices are fully supported and prepared for EPA with their Trainer Coach.

EMPLOYER INFORMATION

EMPLOYER FUNDING

Small/Medium Employers:

Government funding is available to small/medium employers with an annual paybill of less than £3 million, and covers between 95-100% of the costs for apprenticeship training.

Large Employers:

For employers with an annual paybill of more than £3 million, the Government automatically sets aside funds from your business for apprenticeship training in a digital account called a Levy fund.

Incentive grants

Incentive grants are available to small, medium and large employers hiring 16-18 year olds and those aged between 19-24 with an EHCP.

APPRENTICESHIP LEVY

The Apprenticeship Levy requires UK employers with annual paybills over £3 million to pay 0.5% of their payroll into a fund for apprenticeship training. These funds can be used for training or transferred to other businesses, though transfers are capped at 25% of the total. Unused funds expire if not spent.

Many large racing organisations often struggle to use their Apprenticeship Levy. Unspent funds can help smaller businesses with paybills under £3 million to hire apprentices. British Horseracing has partnered with the Co-op Levy Share to make it easier for organisations to transfer unused funds or request support.
